



**AP Alternative Assets Releases Financial Results for the  
Fourth Quarter and Year Ended December 31, 2015**

*--Net Asset Value of \$36.42 per unit as of December 31, 2015--*

**Guernsey, Channel Islands, February 3, 2016:** AP Alternative Assets, L.P. (“AAA”, Euronext Amsterdam: AAA) today released its financial results for the fourth quarter and year ended December 31, 2015. AAA invests its capital through, and is the sole limited partner of, AAA Investments, L.P., which is referred to as the “Investment Partnership.”

**Highlights**

- Net asset value at December 31, 2015 was \$2,779.7 million, or \$36.42 per unit, reflecting a net increase in net assets after contributions, distributions and unit purchases of approximately \$72.8 million, or \$0.96 per common unit during the three months ended December 31, 2015.
